- Water Filter: Model 6426, 12" x 2" (30.5 x 5.1 cm), in-line lead removal element that reduces lead from incoming water supply.

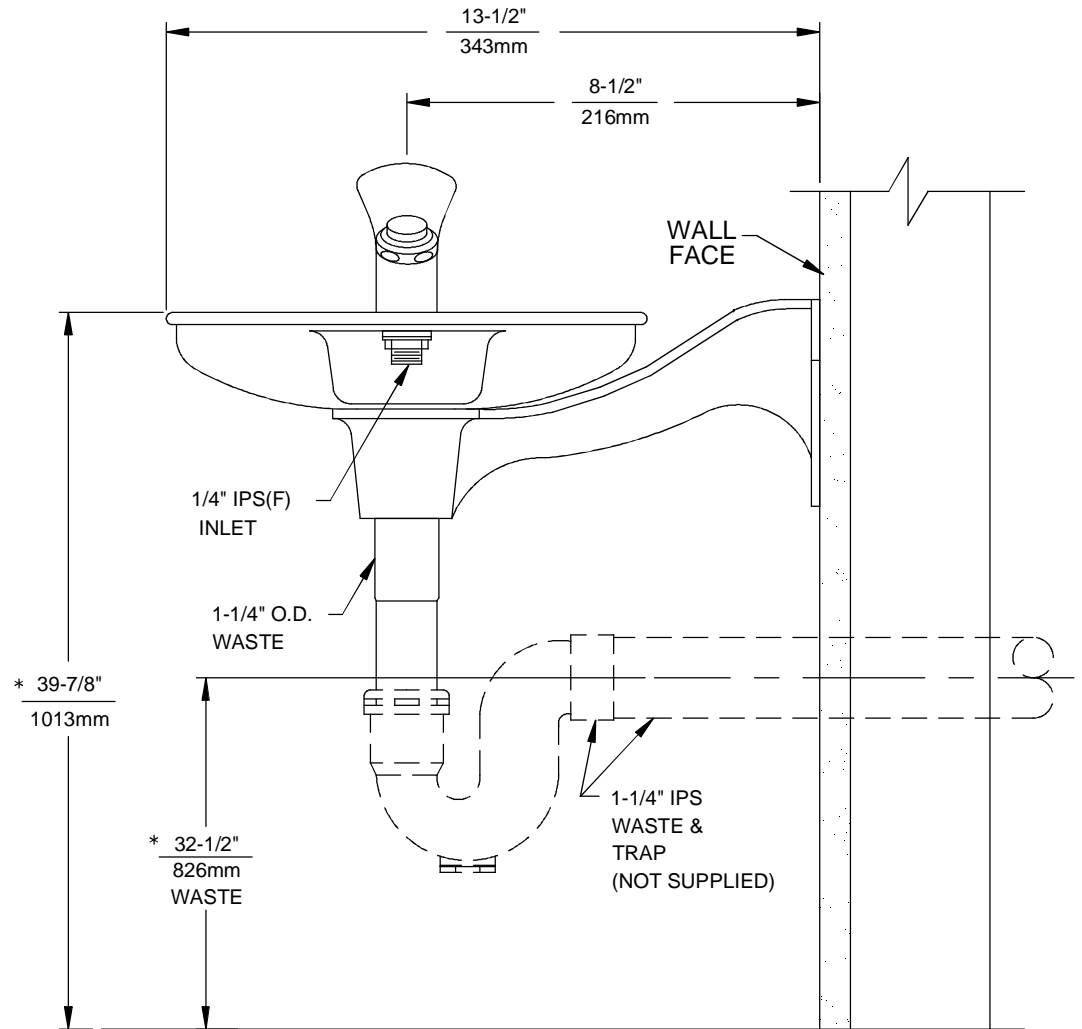
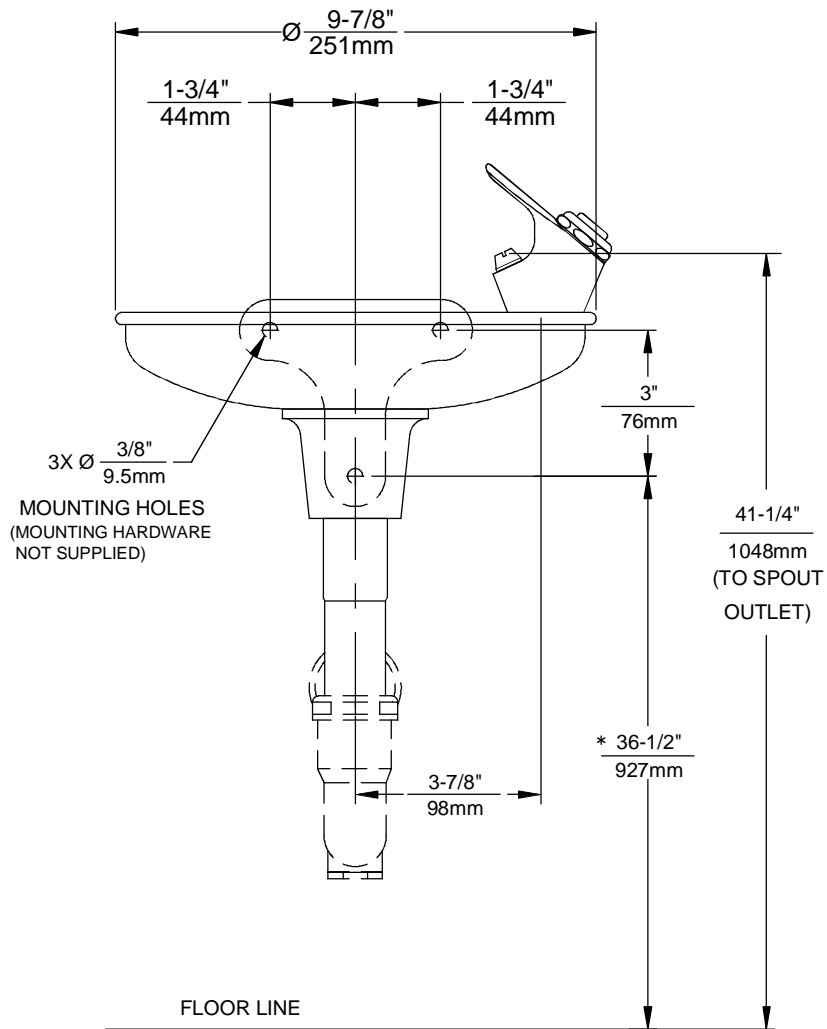
