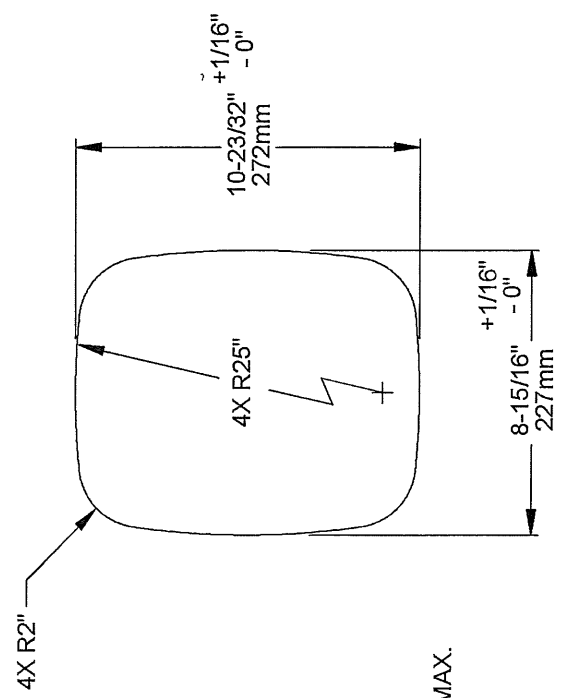
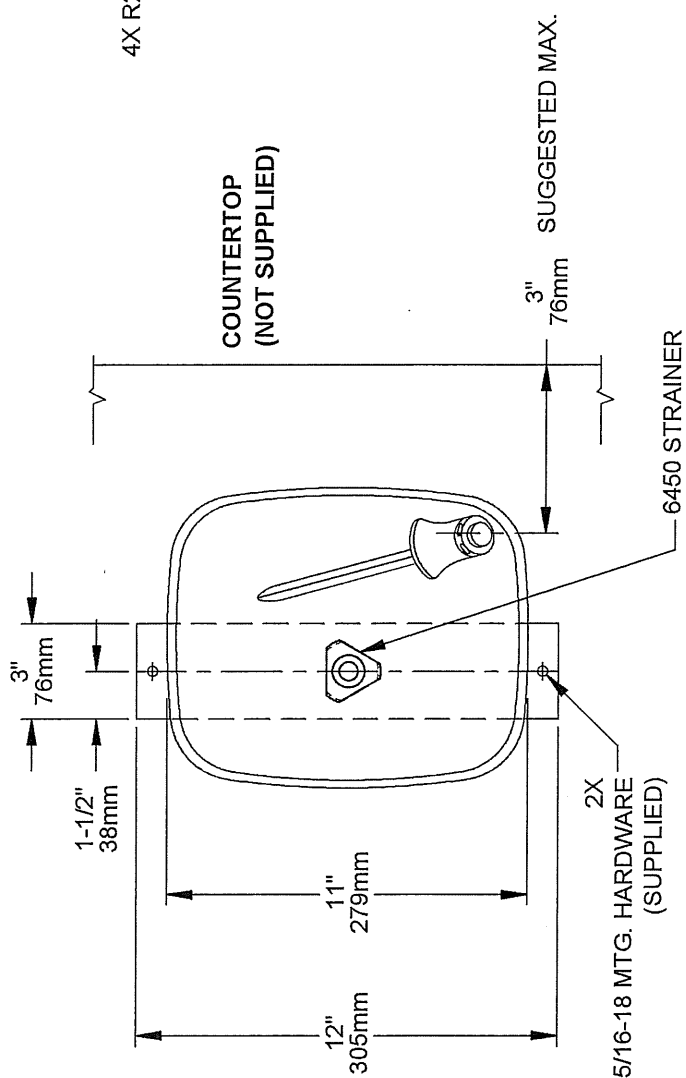
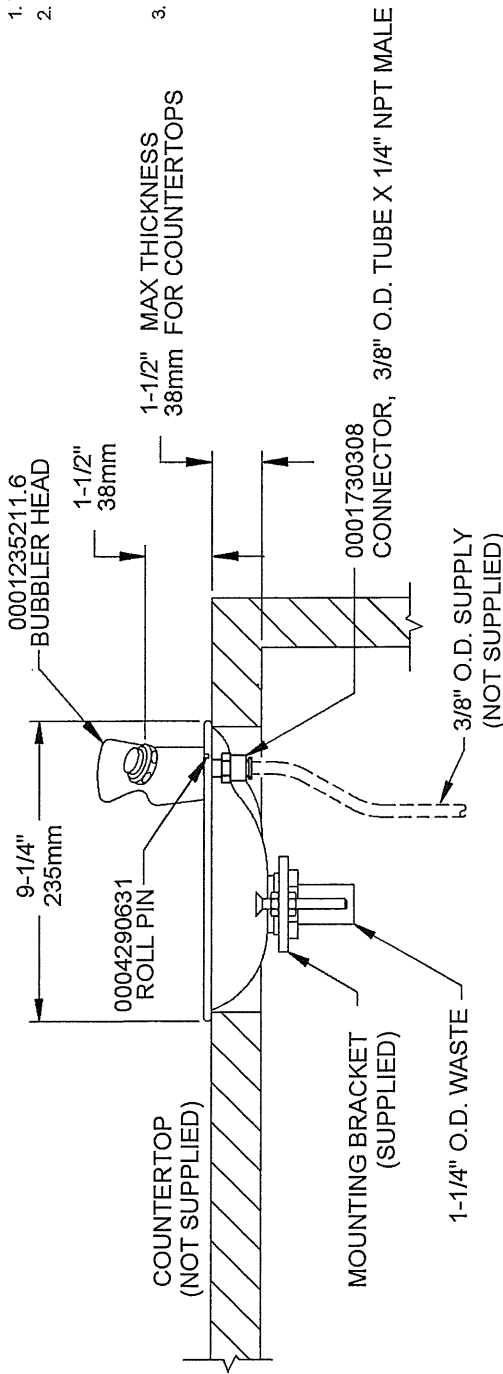


SPECIFICATIONS

Model 4010 deck top sink shall include a Type 304 Stainless Steel, 20 gauge basin, polished stainless steel bubbler valve, cad plated steel mounting bracket with adjustable mounting bolts, and 1-1/4" O.D. tailpiece.

2. FOR ALL PLASTIC PUSH-IN TYPE FITTING CONNECTIONS; PUSH TUBING INTO FITTING UNTIL IT BOTTOMS OUT TO ENSURE A WATERTIGHT CONNECTION. TO REMOVE, DEPRESS THE COLLET AND PULL TUBING OUT. ONLY CONNECT NSF-61 COPPER OR PLASTIC TUBING TO THESE PUSH-IN TYPE FITTINGS.
