**LOCATION OF UNIT:** The Model 7324 Eyewash should be installed in close proximity to potential accident areas. It should be clearly identified, free from obstructions and easy to access.

**SUPPLY LINE:** The minimum recommended line size is 1/2" IPS with 30-90 psi (2-6 ATM) pressure. Where sediment or mineral content is a problem, an inlet filter is recommended.

**PLUMBING CONNECTIONS:** Inlet supply is female 1/2" NPT. Waste outlet is 1-1/2" NPT.

			b.	Probable clogging of flow control due to inadequate line flushing. Unscrew eye/face wash head and remove the four screws to disassemble the head. Clean flow control and reassemble head. See SP65 Installation Drawing for details.	
3.	Eyewash stream does not meet desired eye level.	3.	a.	Possible blocked flow control, see above solution.	
			b.	Possible non-leveled eyewash assembly.	








