**SUPPLY LINE:** The minimum recommended line size is 1" IPS with 30-90 psi (2-6 ATM) flowing pressure. Where sediment or mineral content is a problem, an inlet filter is recommended.

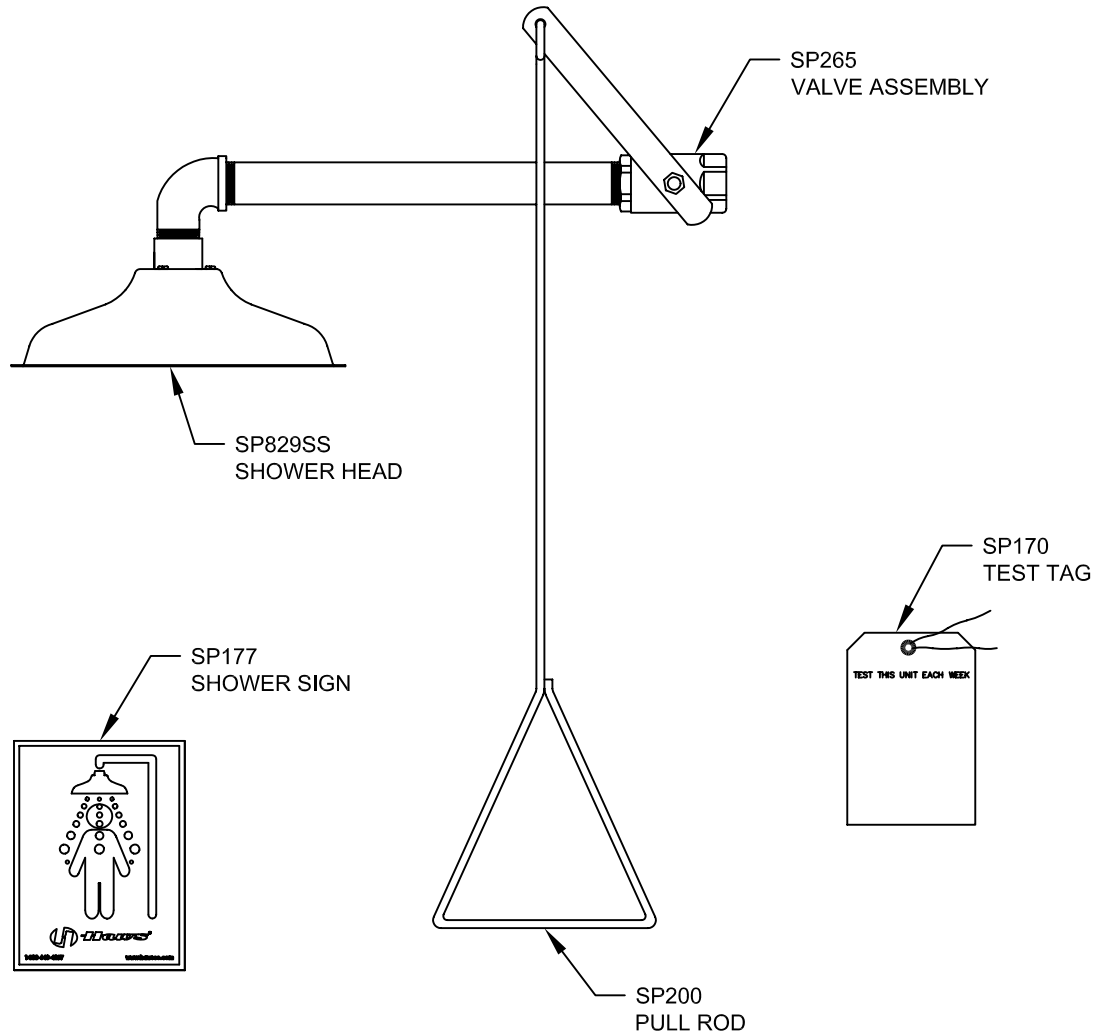
**PLUMBING CONNECTIONS:** Inlet supply is female 1" IPS.

PROBLEM	REPAIR CHECKLIST
1. No flow.	1. Check the main shut-off valve.
2. Insufficient water flow.	2. a. Verify minimum 30 psi (2 ATM) flowing supply line pressure. b. Probable clogging of flow control inside showerhead. Unscrew showerhead off of elbow and clean rubber flow control.

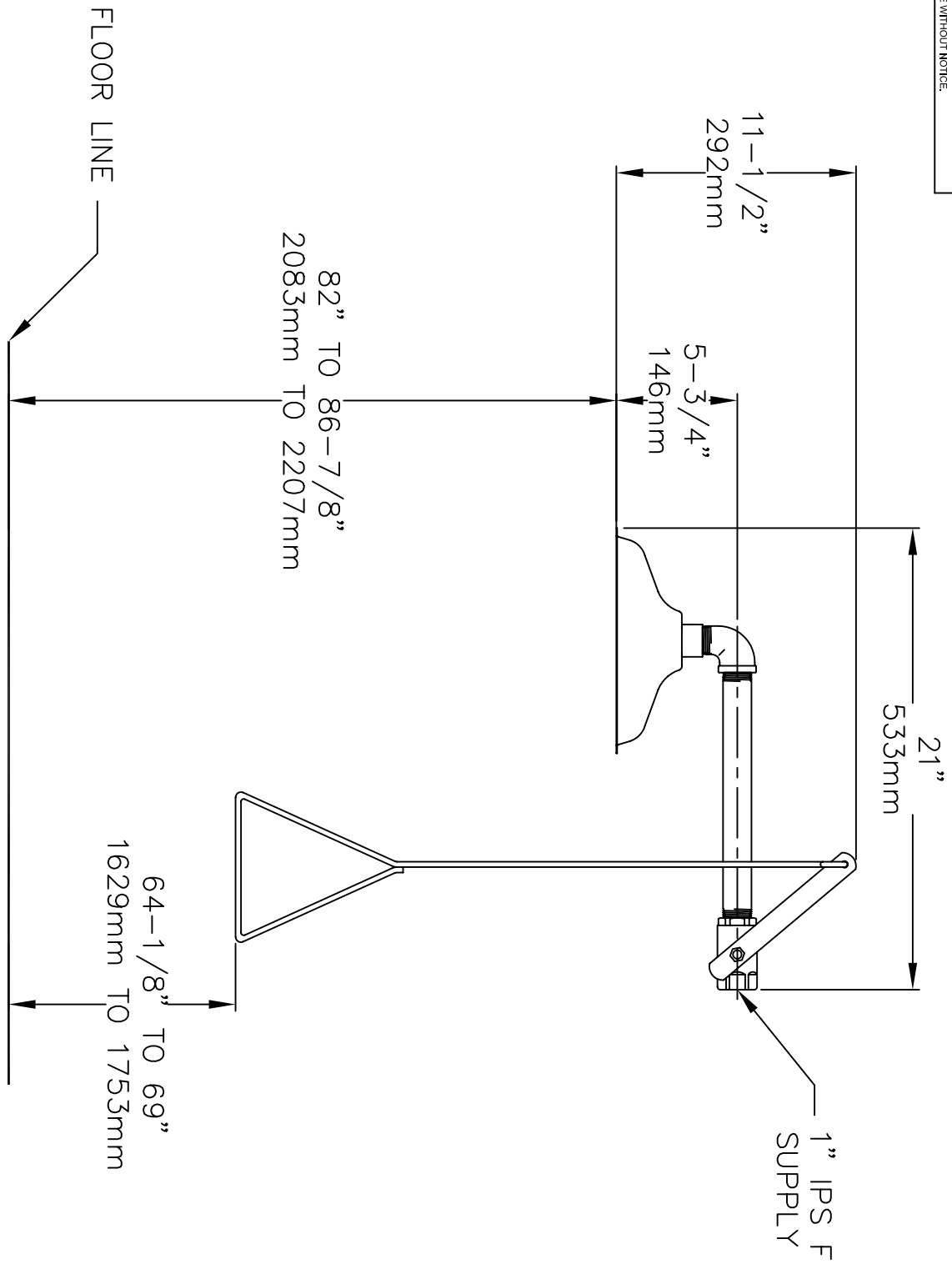

  - SHOWER SPRAY PATTERN SHALL HAVE A MINIMUM DIAMETER OF 50.8 CM (20 IN.) AT 152.4 CM (60 IN.) ABOVE SURFACE ON WHICH USER STANDS, AND CENTER OF SPRAY PATTERN SHALL BE LOCATED AT LEAST 40.6 CM (16 IN.) FROM ANY OBSTRUCTION.
